Length of article

The length of articles for the college magazine should range between 400 to 1000 words. This range allows for sufficient depth of exploration on a topic while ensuring that the content remains concise and engaging for readers. Articles should aim to provide valuable insights, analysis, or storytelling within this word limit, allowing for meaningful contributions to the magazine's content while respecting the readers' time and attention span.

Outlines of article

The structure and content of articles within the magazine will differ depending on the specific subject being addressed. This variability allows for flexibility in organizing and presenting information in a manner that best suits each topic's unique characteristics and requirements. For instance, an article discussing environmental sustainability might include sections on campus initiatives, academic integration, student-led efforts, and technological innovations, while an article about student mental health might focus on

resources, coping strategies, and personal narratives. By tailoring the outline to fit the topic, the magazine can effectively address diverse issues and interests within the college community, ensuring relevance and engagement among readers.

APA citations

For writing a citation-based article, authors should follow the APA 7th edition style to ensure consistency and academic integrity. The text should include in-text citations with the author's last name and publication year, such as (Subba, 2020). If quoting directly, page numbers should be included, for example, (Subba, 2020, p. 45). Additionally, the reference list should be arranged alphabetically by the author's last name. Each reference should have a hanging indent, meaning the second and subsequent lines of each entry are indented. References should include the author's name, year of publication, title of the work, and publication information, such as the publisher for books or the journal title and volume number for articles. This format ensures clarity, enables readers to locate sources, and adheres to academic standards for proper citation (American Psychological Association, 2020).
